Wisdom – to cherish knowledge is to know wisdom.

To share the knowledge, experience, understanding, common sense, and insight of the Indigenous mental health profession with our members and followers.

Love – to know love is to know peace.

To love, respect, and support our members and the work they are doing to improve the quality of life and well-being in our Indigenous communities.

Respect – to honour all of creation is to have respect.

To use language that is respectful to all communities and nations.

Bravery – to face life with courage is to know bravery.

To stay connected to our members and followers, enabling us to stand up for the best of others so we can promote a peaceful and kind environment.



Honesty – to walk through life with integrity is to know honesty.

To communicate and share information with integrity and in an ethically and culturally appropriate way.

Humility – to accept yourself as a sacred part of creation is to know humility.

To show sensitivity towards others, respecting their way of doing things and listening to them.

Truth – to know all these things.

To speak our truth and use our traditional teachings as the foundation for supporting our members, followers, and the work we do as Indigenous mental health professionals.
