### **Membership**

According to the last membership update from the CCPA national office, the Spirituality in Counselling Chapter (SCC) has 360 member total as of April 2021. This includes 279 professional members, 4 guest members, 2 PEICA-PCC Professional Member, 8 QCA Professional Member, 64 student members, and 3 student representative. This is an increase of 56 members from 2020. As an Executive we will continue to explore ways to increase our membership and further expand the knowledge and capacity of all CCPA members in the area of the spiritual domain of health.

### **Past Activities**

#### **General Activities**

- The SCC Executive has been meeting approximately once per month (minus July and August) of the last year.
- The president has been regularly engaging in CCPA President's meetings.
- Hosted first ever virtual AGM in May 2020 after it was announced that the CCPA national conference would be cancelled because of COVID-19.
- Creation of an SCC Facebook page to help distribute information, resources, and professional training opportunities in the area of spirituality
- Redesigning the SCC brochure to promote a more inclusive vision for the Chapter.
- Distribution of a trimonthly email.
- Disability training for all Ontario SCC Executive members.

#### **Knowledge Translation Activities**

- Two abstracts were accepted for the CCPA National Conference 2020. This included an oral presentation and also a panel presentation, however, due to the conference being cancelled these were not presented.
- An abstract was successful submitted for a “Panel Session” on spirituality in counselling for the CCPA National Conference 2021. This panel session was recorded and is currently available for participants registered for the conference.
- Hosted a webinar on “spirituality in counselling” at the 2020 AGM.
- Hosted a webinar on burnout and boundaries by Brandon McElhaney (Vice-President) in April, 2021.
- Preparation and submission of application for a webinar on moral injury scheduled for June 2021 by Lorraine Smith-MacDonald (President)
