

CEC Activity Breakdown

Canadian Certified Counsellors (CCCs) are required to accrue a minimum of 36 Continuing Education Credits (CECs)

Specifically related to counselling and/or psychotherapy over the course of each three-year certification period and required to provide documentation of engagement in these professional development activities. A well-rounded professional will record a variety of Learning Activities and Professional Contributions. The chart that follows provides current information related to CCPA's eligible areas of continuing education. Members holding a CCC or CCS designation who have been selected for audit must submit supporting documentation for the activities for which they are claiming credit. The corresponding supporting documentation is provided in the information below.
